If any goods manufactured or integrated by Ifara Tecnologías, S.L., fail to conform to these warranties, Ifara Tecnologías, S.L., will, as its sole and exclusive liability hereunder, repair or replace such goods if they are returned within the warranty period.

These warranties are made upon the express condition that:

- (1) Ifara Tecnologías, S.L., is given prompt written notice upon discovery by Buyer of such nonconformity, with a detailed explanation of the alleged deficiencies.
- (2) Such goods are returned to Ifara Tecnologías, S.L., at the expense of the Buyer.
- (3) Examination of such goods by Ifara Tecnologías, S.L., discloses that the nonconformity actually exists and was not caused by accident, misuse, neglect, alteration, improper installation, improper repair or improper testing.
- (4) The goods have not been altered, modified or changed in any manner by anyone other than Ifara Tecnologías, S.L., or its authorized representatives.
- (5) Repairs to the goods have not been made by anyone other than Ifara Tecnologías, S.L., or its authorized representatives.

Ifara Tecnologías, S.L. will have a reasonable time to repair or replace such goods. All charges for labour, parts and return shipment of NONWARRENTED goods shall be at the expense of the Buyer. These warranties may be modified in the case of particular goods by warranties set forth on warranty certificates enclosed with the goods at the time of packaging.

IFARA TECNOLOGIAS RESERVES THE RIGHT TO MAKE CHANGES IN DESIGN AND CHANGES OR IMPROVEMENTS UPON ITS GOODS WITHOUT NOTICE AND WITHOUT IMPOSING ANY OBLIGATION UPON ITSELF TO INSTALL THE SAME UPON ITS GOODS THERETOFORE MANUFACTURED.

IN NO EVENT OR CIRCUMSTANCES, SHALL IFARA TECNOLOGIAS BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGE CLAIMS, INCLUDING CLAIMS FOR LOSS OF MATERIALS, TIME OR PROFIT.
